If nomination papers for an incumbent officer of the city are not filed by August 7, 2020 the voters shall have until the 83<sup>rd</sup> day before the election, August 12, 2020, to nominate candidates other than the person(s) who are the incumbents on the 88<sup>th</sup> day before the election, for that incumbent's elective Office. This extension is not applicable where there is no incumbent eligible to be elected.

If no one or only one person is nominated for an elective office, appointment to the elective office may be made as prescribed pursuant to Election Code S 10229, Elections Code of the State of California.

Declaration of Candidacy forms may be obtained from the Inyo County Clerk's office in Independence or at the District offices. Forms are first available July 13, 2020 and must be filed no later than August 7, 2020. If an incumbent has not filed by this date any qualified person, other than the incumbent, may file by no later than August 12, 2020

If by August 12, 2020 an insufficient number of persons have filed for any of the above offices, and a petition for an election has not been filed, appointment to each elective Office will be made as prescribed by law\_
